Business Action/Discussion Items:

Out of State Travel - Cross Country to Seaside, Oregon – A motion was passed to approve the out of state travel for the Cross Country Team to travel to Oregon; motion carried.

Fuel Bid Award – The annual fuel bid was advertised to accept bids and no bids were received. Masco and Fast Fuel provided a cost proposals which were the same. The board was asked to make a recommendation on either Masco or Fast Fuel. A motion was passed to accept Masco's proposal; motion carried.

Budget Extension Resolution 397-14 – No discussion; a motion was passed to approve resolution 397-14 as presented; motion carried.

Field Project donation of \$5000.00 from Montesano Youth Soccer Club – a motion was passed to accept the donation from Montesano Youth Soccer Club for \$5,000.00; motion carried.

Year Round School – Discussion – Steve Poler, Board Chair, presented the idea of year round school and wants to discuss how it impacts education. He suggested having some public forums and would like to have parents, students, community members and staff give feedback on their thoughts. He would like to add the discussion on the next month's agenda and discuss the some of the research and different school schedules.

Turf Project: Superintendent Winter reported to the board that proposals from two companies indicate the need for drainage materials. A study and plan will need to be completed by a civil engineering and landscape architect company. Mr. Winter is proposing the board approve entering into a temporary contract for those services. The estimated cost of the study and plan is \$20,000. - \$25,000. A motion was passed to approve the expenditure up to \$25,000. for engineering services for the Turf Project contingent upon OSPI rules on contracting services; motion carried.
